

# Black coalition shocked by NAACP moritorium on public school charters

CINCINNATI—BAEOThe president of the Black Allianace for Educational Options (BAEO) expressed shock and dismay at the decision of the NAACP to suport a moratorium on school char-

The NAACP Board of Directors voted to ratify a resolution in support of a moratorium on all new charter schools during the organization's fall board meeting in Cincinnati, Ohio.

The ratification came despite hundreds of letters from Black leaders and parents encouraging the NAACP to reject efforts to deny parents educa-

"We are absolutely stunned that the NAACP voted to put distortions, lies and outdated ideologies about charter schools above what is in the best interest of our children," said BAEO President Jacqueline Cooper in a statement following the vote. "It is inexplicable to me that such a storied organization, responsible for leading a powerful civil rights movement to tear down barriers for generations of Black people, would erect new ones for our children."

Not all charter schools are perfect, she said. "Just like traditional district schools, some are working very well and some are not. High-quality schools should be supported and schools that are not educating our children should be improved or closed. But with more than 700,000 students enrolled on charter campuses, we must continue supporting them just like we must continue supporting traditional district schools to make them better for our children.

"Banning new charter schools will only widen the achievement gap for Black children by reducing the number of high-quality options available and increasing the number of names on existing waiting lists. Low-income and working-class Black families deserve more choice, not less."

As tragic as this decision is by the NAACP's Board of Directors, BAEO remains committed to working with the organization in areas where we mutually agree to increase access to high-quality educational options for low-income and workingclass Black families.

#### to divide and conquer by Mikel Holt Milwaukee's status as the country's most segregated city makes it an ideal center to initiate a new multi-racial movement, Minnesota's first Black congressman declared Friday. Speaking at the 27th Annual James Baker Award Dinner, Rep. Keith Ellison

(D-MN) told the audience gathered to honor this year's recipient, Wanda J Montgomery that Black Americans need to be at the vanguard of a new movement to build racial solidarity.

The racism, bigotry and misogynist undertone that has defined this year's

presidential election is not accidental, Ellison declared, adding there is a strategic objective behind the rhetoric that has tainted the campaign. "It's not just the random rambling of a crazy fool; although Donald Trump

is that," he said to laughter. Instead, the election is about the desires of the 1% who control 75% of the nation's wealth, maintaining control over the majority. It's money vs. man he said, the rich seeking to undermine the democratic process to benefit their

"In our democracy, one person's vote is (equal) to their (rich) one vote," he said, but it only takes 50% plus one to nullify the interest for the majority by maintaining policies that benefit the few; to support a social and economic

agenda that only benefits the 1%. Because the majority outnumbers the privileged, they must deceive and divide voters. "The Koch brothers have no interest in the will of the people," he continued. "They don't want the democratic system to tell them what to

Unfortunately, too many grass root citizens think because they have right on their sides, "that's good enough. But right is not enough," he said.

People must mobilize and fight to make democracy work for their best in-

America is politically and socially polarized today as a result of a concerted effort to pit different ethnicities against each other, he continued.

"What does a construction worker have in common with Donald Trump?"

he asked rhetorically. Nothing, unless that Trump supporter can be convinced that he has "White privilege," and that minorities and the poor are responsible for their plight:

the loss of jobs and tax dollars being diverted to social services. One way to tear down the wall of racism and misconceptions in America is to convince the supporters of the 1% that racism hurts White people as well

as minorities, Ellison theorized. A byproduct of Florida election scandal of 2000, during which the congressman said Black votes were purged from the voting rolls, was the election of George Bush, who in turn started an unnecessary and unjustified war in

The Southern strategy under Nixon, based on racism, ushered in the war on drugs, which was designed to hurt Black Americans but eventually, hurt Whites as well.

Iraq that resulted in 5,000 Americans being killed, most of whom were White

Racism also influenced the election of Ronald Reagan and "we are witnessing a similar 'strategy' today with the appeal of Donald Trump.

Unless people can begin to look beyond melanin, and work together for the benefit of all Americans, we will continue down a path that divides the country and hinders true democracy, he explained.

Conversely, Black Americans must make the Democratic Party more ac-

# For eight decades Social Security has provided a needed safety net

For the past 81 years Social Security has provided a financial safety net for Americans. It continues to support and provide income for people who are retired, disabled or a survivor of a loved one. Social security offers a foundation for financial security for millions of people who would otherwise not be able to financial support themselves. While the bulk of your retirement savings will come from your employer sponsored plan, personal savings and investments, Social Security helps replace about 40% of preretirement earnings for the average worker. Congress recently passed new rules that affect how and when married couples can claim Social Security. Let's explore what those changes are and what

The first change affects "file and suspend". If you suspend your benefit after April 29, 2016, benefits payable to others on your record are also suspended.

The second change affects "restricted applications". If you were born after January 1, 1954, you must file for your own benefit before you can collect

The best way to describe the changes is to use an example. Mary and John are full retirement age and want to use half of John's benefit to live on while both spouses continue to earn credits to increase their own benefits by up to 8% per year. To do this, John "files and suspends" and Mary files a "restricted application" to receive 50% of John's benefit. Both continue to earn credits to increase their own benefit while Mary collects the spousal benefit. The new rule no longer allows couples to do this. Mary cannot collect a spousal benefit on John's record if he requests suspension after April 29, 2016. Now, Mary can only collect the spousal benefit if John is collecting his. Let's be clear, you can still "file and suspend" but your spouse and no one else can receive a benefit based on your work record during the suspension. If you suspended before April 30, 2016, the old rule will continue to apply. The second change affects Mary's ability to file for spousal benefits and delay filing on her own record. If Mary was born before January 2, 1954, she can still file for spousal benefits at full retirement age without having to file on her own record. If Mary was born after January 1, 1954, she must file for her own benefit first, even if she is full retirement age.

These new rules now really require couples to think smart and carefully about the best time to claim for benefits. Things to consider are your health, financial situation, financial goals, and how long you can and want to work. Each couple's situation is different and you have to make the best decision for your circumstance. Everyone is eligible to claim at 62 but your amount will be greatly reduced; however, if you wait to claim at 70 your benefit increases by 76%. The goal here is to delay claiming as long as you can. Once you begin receiving benefits that is what you will collect for life. Got questions about your social security, AARP's Social Security Q&A Tool (www.aarp.org/moneytools) can help. Recently, politicians have even gone after the Social Security Administration. Cuts to the SSA make no sense--it makes it hearder for seniors to et the help they need. Not to mention administrative costs only make up .9% of an-

We need Congress to get its act together and protect this vital government program. Senator Johnson needs to know that seniors are paying attention, and we won't stand for any attempts to cut or privatize Social Security!

# Did Jesus Weep: Because Black Lives Matter Too?

For the last four visible years America has endured, once again, the polarizing effects of racism and injustice. Yet, instead of the perpetrators wearing white sheets and lynching African Americans and with coral ropes as they did decade's prior, they now wear blue uniforms and use issued firearms.

The loss of Trayvon, Eric, Tamir, Sandra, Freddie, Korryn, Alton, Terence, Keith, and all of the others we name, came not because their assassins feared them but, because they believed their lives didn't matter. Secretly, I've wept at my core when I hear the news that they have taken another life Even when I'm driving my car with my 2-year-old Zayden, I pray that our

As the numbers of African-American lives continue to be disproportion-

ately taken, many onlookers (primarily Millennials), have come with demands and questions about whether those in power believe that #BlackLivesMatter. And if so, why is injustice prevailing in the loss of these lives? The Black Lives Matter movement does not assert that other's lives do not matter. It aims to draw attention for the need for understanding if those who enact, execute, frame and inform the law also value Black

In my youth, every evening we had to offer a scripture, after prayer, before we could partake of supper. We would all eagerly go for "Jesus Wept" because it was the easiest to remember. As I sit most evenings unable to eat sickened to my stomach, praying and searching the scripture for meaning, I ponder why did Jesus weep.

The scriptures have three recordings of Jesus weeping. The most notable is because he loved Lazarus, and Martha and Mary. Even in knowing that Lazarus would be raised again, Jesus' human nature and pain mourned, both in relation to their present pain and even their unbelief. Jesus also wept when the chosen people failed to keep the city 'holy' and set apart from other world powers ...He saw the city and wept over it. The other prominent presence of his weeping is found in a garden. Jesus wept sweat '...like great drops of blood," as he prayed to his Father, knowing his time had come to die for a humanity that might never get it.

Why did Jesus weep? Was it because he was fully human and, yet, fully divine, feeling the spiritual and nature pain of the people? Was it from his humanity and divinity, where he felt love, disappointment, loss, grief and sadness-every human emotion that evokes tears from the heart?

One doesn't have to be dead to grieve death and dying. Grieving calls us into an experience of raw immediacy that is often devastating. In A Grief Observed, a collection of reflections on the experience of bereavement, author C.S. Lewis reveals that "No one ever told me that grief was so much

Tears, the lachrymal gland, responds to the emotion of awe, pleasure, love and, yes, sorrow. They are the fluids that rest in the ducts that can cause you to lose sight and can run down into your nose, all because of sorrow not joy. And, when the heart weeps it is beyond the liquid into the small channels that flow into the tear sac.

It is a pain that is likening to the sound of sorrow from the mothers, fathers, family members, who have lost their loved ones in the midst of these

"I am not afraid, but the sensation is like being afraid. The same fluttering in the stomach, the same restlessness, the yawning. I keep on swallowing." As an African American male, I can relate to Lewis because seemingly everyday my life is at risk. I swallow grief and fear that I, or one of my brothers, our children, or mothers, are next.

It was the sorrow of a suffering people that gave cause to ecumenical faith leaders becoming the catalyst for a civil rights movement for a "Right-

These faith leaders used their sacred spaces to address the grave concerns for the least-advantaged among them. As an American society founded on a hunger and thirst for religious freedom was turning a deaf ear to the pleas of a marginalized people, certain that God's creation suffered no stratification; these likeminded humanitarians, across racial identity, leading the charge for equality. They understood why Jesus wept, as did Jehovah, Allah, the Buddha, and many others spiritual leaders who wept too.

Recently, America lost an African-American male musical icon, Prince, though not at the hands of those in Blue. I mostly remember him for Purple Rain, in particular "When Doves Cry." Though is it understood that these lyrics spoke to a failed relationship between two people, I purport that it speaks more to the sound of the doves. When doves cry, as they soar, it is a sorrowful song and yet in the sound we find a message of life, hope, re-

Could the Prince of Peace be sending us a prophetic message that even in these moments of tragedy there is hope for better days? As we stand through our sorrow, will we be able to earnestly declare that #BlackLives-Matter too?

Funeral services will be held Friday, 12 noon, for one of the original Commandoes, the civil rights group that led the Open Housing Marches that helped end segregation in Milwaukee.

Larnal 'Jabo' Friend was a member of the group of Black men who led thousands of Black Milwaukee in a year long campaign in support of a city 'open housing ordinance' that would end legal housing segregation in Milwaukee in 1967. He also participated as a member of the NAACP Youth

Friend was born June 9, 1948 to the union of George Friend Sr and Eller Mae (Toombs/Bursey) in Lauderdale County, Tennessee

He moved to Milwaukee at a young age and attended Milwaukee Public

As an adult Larnal (JABO) was greatly loved and a huge part of the business' community. He owned and operated LF Transportation Trucking, night clubs, restaurants and a car wash. In his leisure he restored classic cars.

His favorites were a Rolls Royce and Triple Black Camaro.

Friend was known as a trend setting dresser, and he loved R&B music and soul food 'cooked from scratch.'

According to a family member, he "always told everyone he encountered what they needed to hear, NOT what they wanted to hear. He was very outspoken and didn't mind if the truth hurt. Family and friends included.

Jabo departed this life on October 11 doing what he loved: fishing at Lake Monona in Dane County. This was one of many favorite places he fished, relaxed and enjoyed the peace and tranquility that came with being outdoors.

The appearance is open to students, faculty and the ublic.


Wright also will return in 2017 for an event that will feature a reading of one of his plays.



Born in 1934 in New Mexico, Wright's early exposure to Mexican, Spanish and Navajo cultures has had a lasting effect on his poetry. His poems explore history from this multicultural standpoint and often take the form of allegorical journeys and spiritual quests.

She mentored the all-female secondary school national champions for the British Council's Power in the voice initiative and has been guest writer for Warwick University's International Gateway for Gifted Youth.

Her poetry has appeared in international journals including the Swedish magazine 10Tal, Cordite, Rio Grande, Sampsonia Way and Spanish translations of her work in the Mexican journal Ofi Press.

Her thoughts on writing and gender appear in the aptly titled Gendered & Written (Locked Horn Press, 2014). She is a widely anthologized poet and has recorded various spoken word poems to house music that have made it on to Botswana's radio countdown lists. 



it is telling young men to be pimps, and calling Black women "ho's and bitches."

Again I digress.

I remain confused about who Dud is referring to when he criticizes "America" for producing the slavery films. I assume he was talking about White people, but here again, he's off base.

"Roots" was written by a Black man, Alex Haley, to trace his ancestry back to the Motherland (that's Africa, Snoop, where all life originated and God decided to plant His first shade tree and Black people to sit up under it.

(By the way Snoop, we didn't come from some country called "Niggerland," nor did we arrive at Ellis Island on Soul Plane.)

Moreover, a brother produces Underground, and Birth of a Nation is produced, and stars an excellent cast led by its lead writer and director.

The storyline is based on uncensored history, and its title should be worthy of discussion by itself, because it was also the title of turn of century racist propaganda film that gave "birth" to the Klu Klux Klan, lynchings and the establishment of apartheid to replace slavery. Or maybe we're smoking those doggy weed briskets that the Dud is proud of inhaling in public.

Social scientists have theorized that much of Black America suffers from a form of PTSD that is rooted in the painful experiences of slav-

ery that continue to plague our subconscious.

Others, including myself, believe too many of us (particularly those like Doggy Dud who look in the mirror and see a "real nigger" staring back), continue to live under a cloud of slavery.

This hypothesis surmises that Willie Lynch's socialization process worked.

Lynch supposedly taught "slave owners" on how to control their property. The process included pitting light against dark, big against small, castrated men against overbearing women and using Christianity to pacify them.

If correctly carried out, the slaves would see themselves as "niggers" for several hundreds years, generation after generation.

It is a true story, our story, and we have to tell it. I know that our story didn't begin with slavery. So Roots tells us where we began before we were enslaved—we were Kings and Queens, we were royalty, warriors, we had knowledge, we had life, and we had joy."

He continues, "In the video you (Dogg) stated, "I don't understand America, they want to keep showing the abuse that we took."

"But have we learned enough about us being Kings and Queens before the time of slavery, or what life was like before it, also?

"So, Snoop Dogg, you should be championing it," he continued.

"You should be proud of Roots because the culture behind the message in your music is poisonous compared to Roots. You use the N-word while getting high—what is that contributing to this world? If I were you Snoop, I would look back into history, Roots tells us how we came here and how we were betrayed by whites.

"Neither side was shown in the

best light. Enslaved women were raped and killed in front of their kids while the Whites who were doing this considered themselves Christians. Then came another generation of whites—whites that separated themselves as pure Christians. They were telling our ancestors; whatever they had been through, there will be another side of their pain where there will be joy again.

"We have to take that positive message and send it on to the next generation. That is why it is important every person from every culture in this world should watch it.

Excellent points. I would only add that ours was the first civilization. Our people created math, and science and astrology. Our ancestors, Mr. Dogg, created the first college known to mankind when

Europeans were living in caves. And centuries before that, our ancestors realized that there was but one God.

Far too few of our people are aware of our history before the Mayflower. Our children are lost because they don't know. And they can't create a path for the future unless and until they figure out where they came from and how they got here.

When I look in the mirror, I see the descendent of kings and queens, not the nigger (excuse my use of the word, I detest and normally would not use it, but it's soooooo appropriate here), the Doggs sees. And I share my mirror with my children and every one else who will listen and are interested in empowerment.

If you see the descendent of the

man who created math in the mirror, you know you can do it. If you know we created medicine, you know it's in your blood and you can serve. And if you realize your ancestors survived slavery, redefined Christianity and overcame the odds, you know there is nothing you can't do.

I'm thinking about purchasing a video of Roots and mailing it to the Dud. Maybe when he's in one of his usual dope clouds, he'll mistake it for one of his porn movies and put it in his VCR. Who knows, he may learn something that'll get him higher than the weed he's using.
