Budget Works

"Beyond simply adding and subtracting a list of income and expenses, taking into account your priorities and goals can help ensure you create a practical budget that works."

(Family Features)--You may think that creating a household budget is as simple as adding all your income and subtracting all your expenses, but there is (or should be) quite a bit more to the equation.

When you only factor in your current earnings and current expenses, you'e not planning for the future. That means any financial goals can be easily deferred, and you may be overlooking the opportunity to shift your spending habits. #### 1 Take long-range goals and values into account.

Some people also consider groceries as another area where you have some discretion, as to some degree you can shift your purchases to fit your budget. In the last category, account for non-essential spending like entertainment, clothing and personal care, such as haircuts, massages and manicures.

#### 3 Pay yourself.

When you're focused on the money leaving your bank account each month, it's easy to overlook the importance of keeping some of that money for yourself. Whether you're saving for a long-range goal, simply stockpiling reserves against unplanned events or working toward retirement (or even better, all three), setting aside money each month is an important step in creating a healthy budget.

Having money set aside not only puts you in a better position to satisfy your goals, it can help you avoid unnecessary stress when life throws you a curveball. A healthy

savings account also means you can recover more easily and keep your financial commitments on track when unexpected expenses arise.

carrying that debt for years before it's fully paid down.

**Employee purchase programs:** Research shows that financial stress at home regularly impacts employee productivity at work. "We need more job training," that's what we continue to hear from people in poverty.

Two local social service agencies are actively responding to the cry for help.

The Social Development Commission (SDC), in partnership with HeartLove Place, are offering the ProStart Culinary and Job Training program that provides a comprehensive, 400-hour training program approved by the National Restaurant Association.

The 14-week program begins Monday, May 8, 2017. Classes are Monday through Friday, from 9:00 AM – 2:30 PM at SDC's Teutonia location (6848 N. Teutonia Avenue, Milwaukee).

The comprehensive course includes both classroom work and hands-on culinary training addressing food service practicums such as food safety, cutting techniques and preparation of dishes that are critiqued by judges.

Participants also receive job readiness skills training with an emphasis on résumé writing, interviewing, dress, telephone etiquette and social media dos and don'ts.

Students must pass the ServSafe and ProStart examinations to be considered employable in the industry.

"Over and over we hear of the need for job training. Parents working three minimum or low-wage jobs still leave families in poverty and children suffer because their parents are at work all the time," stated SDC CEO George Hinton.

"SDC is working to provide and expand job training programs to help people obtain jobs that can sustain individuals and families, and work to make a dent in reducing generational poverty."

HeartLove Place partnered with SDC to provide job training components to the program that they don't offer. "HeartLove Place has operated the ProStart Culinary Program since 2005, with at least a 90% graduation rate and job placement of 51%," said HeartLove Place Executive Director Viola Rembert.

"Our partnership with SDC enhances the course by adding the employability skills and results in well-rounded, certified graduates prepared to enter the industry."

Participants may receive a

needs assessment to address strengths and weaknesses and work with a SDC case manager or HeartLove Place's Family Resource Center. Both entities strive to eliminate barriers ranging from transportation to math and reading.

Attendance at an information session is required. Sessions are being held at SDC (1730 W. North Avenue, Milwaukee), Monday, May 1 at 10am and Thursday, May 4 at 5pm. Online registration is available at cr-sdc.org/programs/career services.

For more than 50 years, the Social Development Commission has operated as the Community Action Agency for Milwaukee County. SDC serves as a planner, coordinator, and provider of human service programs for low-income individuals and families residing in Milwaukee County.

The agency is an intergovernmental commission and is governed by a board of 18 citizens from Milwaukee County, each of whom hold the title of "Commissioner."

## Experiential Interviews: Four Steps to Help You Identify Superior Talent

NEW YORK, NY—Interviewing is a vital part of the staffing process, so in order to select the best talent for your organization's needs, the interview must be

Hiring expert and business consultant Scott Wintrip says that conventional interviews don't work, and that hiring managers across the globe are turning to experiential interviews—the kind where the candidate does real work to demonstrate his skills—to fill positions in their companies.

Why? Because conventional interviews give only the smallest glimpse of the candidate—and an inaccurate one at that.

"During conventional interviews job candidates are always on their best behavior," says Wintrip, author of High Velocity Hiring: How to Hire Top Talent in an Instant (McGraw-Hill Education; April 2017; ISBN: 978-1-2598594-7-2; \$30.00).

"They say what you want to hear and share only the best parts of their backgrounds. This is why the person interviewed isn't always the same person who shows up for work. But experiential interviews allow employers to base their hiring choices on facts instead of guesses."

Wintrip explains that during experiential interviews, you get to see candidates doing sample work rather than speaking conceptually about the job.

During experiential interviews, computer programmers can be given specs to write computer code, accounting candidates can analyze financials, and marketing staffers can design a promotional cam-

"Regardless of industry, embracing experiential interviews can help you find better talent faster," says Wintrip. "When you get to witness candidates doing

the job firsthand, you can automatically assess their skills and instantly have a complete image of the person you've just met. This way, there are no surprises or disappointments."

Keep reading to learn about the four stages of experiential interviews.

Stage 1: Compare the candidate's written materials to your company's hiring profile. Your hiring profile-the specific standards, skills, and qualifications you require job candidates to meetgives you a point of reference when viewing each candidate's qualifications.

Compare all candidates to your hiring profile by viewing their résumés, job applications, plus, if needed, a few written questions. Any candidate who matches the most important skills, experience, and education level moves on to Stage 2.

Stage 2: Conduct a brief phone interview. For most roles, a 20-minute (or less) phone conversation allows you to hear how the candidate communicates as you review their background and discuss the job. This stage also provides an opportunity to discover how their values, helpful behaviors, and personality features may or may not fit into your company cul-

"Effective phone interviews can cover lots of ground using short and simple questions," says Win-

Why us? Motives are important. Knowing whether your candidate is inspired by your company's mission or just looking for a job will help you pick the best people.

Why now? Knowing what's driving a candidate's
